Canvas will be used to post grades, submit assignments, and administer exams. Be sure check your bronco email for any communications from the instructor. Changes and additions to the course may be posted in canvas and/or via email.

<u>Course Description</u>: The causes, description, and treatment of mental illness. Emphasis is on an integrated analysis from a psychosocial viewpoint. Prerequisite: PSY 2010 or 2020.

Expected Outcomes:

- Develop the historic foundation of psychopathology
- Understand the role of cultural factors in the dx/tx of psychopathology
- Knowledge of the major theories of etiology of psychopathology
- Knowledge of the major theories of the treatment of psychopathology
- Knowledge of disorders outlined in the DSM-5
- Analyze critical issues in studying abnormal behavior
- Knowledge of basic legal concerns in psychopathology
- Awareness of the criteria differentiating abnormal and normal behavior

Required Text:

<u>Grading Scale</u>: Total Points = 200; A = 186+ points, A- = 180+ points, B+ = 174+ points, B = 166+ points, B- = 160+ points, C+ = 154+ points, C = 146+ points, C- = 140+ points, D+ = 134+ points, D = 126+ points, D- = 120+ points, F = or < 119 points.

Components of course grade: Midterm = 60 points; Final = 80 points; Group Presentation/Paper = 40 points; Participation/Group work = 20 points. Exams: The exams will consist of multiple choice questions and short answer essay questions. Exams may include material from lecture, discussion, slides, assigned readings, or in-class group work. The final exam will not be cumulative.

In-Class Group Work: will be graded credit/no credit. Group work credit will be tallied at the end of the semester with 90% compliance earning full 20 points. <u>Each student is responsible for submitting the group work individually</u>, even though each group member will turn in the same material. Groups will be formed randomly for each class session's group work. Group work is submitted after class. Making up missed in-class work will not be possible. Please submit work in **word file or pdf format.**

Grades on Canvas: Do not rely on canvas' grading summary. It tends to be inaccurate when using credit/no credit assignments. Please calculate your own total summary and grade by adding up your individual scores and dividing by total possible.

<u>Group Presentation:</u> The final project will be done in an approximately 10 person group. This group will be <u>formed early in the semester via Canvas</u>. Students are responsible for exchanging contact information once groups are formed. All students are expected to contribute equally and do their part.

Each group is expected to present on a specific mental illness focusing on the diagnosis and treatment of the disorder. Note: the intent of this project is to focus on treatment and **not the cause of the disorder**. The duration of the presentation will depend on the number of groups formed (at least 20 minutes). Students may choose any disorder published in the Diagnostic and Statistical Manual – 5. These include mood disorders, anxiety disorders, eating disorders, ADHD, Autism, personality disorders, paraphilias, psychosis, personality disorders, substance use, and trauma. These are just some of the possible areas of focus. The presentation should

describe the disorder diagnosis criteria, include an interview of a counselor/therapist who treats that disorder, describe the major challenges to the counseling process for both client and therapist and, lastly, therapeutic approaches to treatment and efficacy. The presentations must have a visual component (Power-Point, video, brochures), 5-page (minimum) paper summarizing the information, and an annotated bibliography with APA—style references (min of 2 citations per person, only articles published in scholarly journals accepted). In addition, each group will submit a list of responsibilities met by each group member. Keep in mind that your individual grade will reflect YOUR effort and contribution made to developing the presentation. This is not a group grade! There is an addendum posted in the Canvas' assignments tab for additional guidance on this project.

Given the size of this class and the groups, please designate half of the group members to working on the term paper and the other half to the oral presentation. The paper and the presentation should mirror each other in terms of content.

<u>Term Paper</u>: Those assigned by their group to compile the term paper will need to submit the paper into Canvas. This must be submitted the same day as the group's presentation. Each writer must have a minimum of 2 scholarly citations and minimum of 2 pages (APA format) (10 pages total). Each person must submit the paper with their portion highlighted or clearly labeled as their own. The full 10-page paper must be submitted by each of the writers into canvas.

<u>Oral Presentation</u>: Presenters will submit <u>only an annotated bibliography</u> into canvas the day of the presentation. Do not read from prewritten material. Working off note cards is fine. Each presenter must submit the annotated bibliography into canvas. The bibliography will be the same as that submitted with the paper.

All submitted work must be in Microsoft Word or PDF format.

Participation:

Students are expected to attend class, to be on time, and to actively participate in class discussions and activities. Students should come to class having done the required reading for that day and with all completed tasks and assignments. Students should be prepared to discuss the readings and topic for that day, challenge the ideas presented, present their own thoughts and ideas, and integrate these with material from the readings.

Make up Exams:

Make-up exams will be given only in cases of extreme emergency (e.g., passing of an immediate family member, a car accident, or emergency surgery). Emergency must be supported with official documentation.

Title IX: Please note that there are two executive orders from the CSU's Office of the Chancellor that limit what information faculty members are able to keep confidential.
